4. APPLICATION / LIMITATION

4.1 May be used for the following services on board:

- Liquid fuel, heated liquid fuel, lubrication oil, steam, fresh and sea water, compressed air, exhaust gas

4.2 Material of fittings and flanges shall comply with the relevant requirements of Bureau Veritas Rules.

4.3 Taper threaded fittings are not to be used for liquid fuel pipings and oil pipings located in engine room and in spaces containing a source of ignition.

4.4 Temperature reduction factors are to be taken into account for maximum working pressure caused by temperature influence according to manufacturer's specifications.

4.5 The hoses are to be limited to a length necessary to provide for relative movement between fixed and flexibly mounted items of machine/equipment or systems and are only to be used in lengths up to 2 m. The hoses are to be installed in clearly visible and readily accessible locations at all times.

4.6 The use of stainless steel is to be restricted as per the requirements of the Bureau Veritas Rules.

4.7 The hoses are to be installed according to manufacturer's instructions and Bureau Veritas Rules and Regulations stated on the front page of this certificate.

5. PRODUCTION SURVEY REQUIREMENTS

5.1 The products are to be supplied by **AMNITEC LIMITED** in compliance with the type and the requirements described in this certificate.

5.2 This type of product is within the category IBV of Bureau Veritas Rule Note NR320.

5.3 BV product certificate is required.

5.4 Each metallic flexible pipe with end fittings is to be hydraulically pressure tested to twice the maximum working pressure and provided with the manufacturer's pressure test report and conformity of production.
